# **By-law Changes**

The Ontario Not-for-Profit Corporations Act (ONCA) was proclaimed on October 19, 2021. We have 3 years from that date to comply with the act. Sue Flanagan and Nancy Boyce attended a FOCA webinar about ONCA on April 6, 2022.

Two important issues came to light during the webinar.

- 1. Our Corporation is required to have an audit done every year unless the membership votes at the AGM to not have an audit done. We are proposing that an audit be done every 5 years or whenever there is a new Treasurer.
- 2. We need to notify the Ontario government each time there is:
  - a. a change of directors
  - b. an address change

Sue and Nancy conducted a by-law review and discussed the changes at the August 8th board meeting. As a result of that meeting, the following changes are recommended. Other changes may be incorporated once the document is reviewed by a lawyer.

# **Membership Report**

As of October 1st we have 124 members. We had 130 members this time last year and 133 by fiscal year end. We very much appreciate the support of our members and we know there a few cheques on the way. Sometimes people just don't get around to renewing. I've sent two renewal notices and won't be sending anymore this fiscal, so if you're not sure if you've paid, just ask. If we receive payment and you've already paid, I'll apply the payment to subsequent fiscal years.

We stopped accepting cash during the pandemic to make sure our Treasurer could do contactless deposits at the bank. For the current fiscal year, 75% of all payments were by etransfer. These payments were automatically deposited into our bank account and did not result in any cost to the association. We continue to accept payment by cheque and PayPal because it is important to offer convenient options. 58% of payments were for 3 year terms, which saved our members \$5 each over the 3 years. Multiple year renewals reduce our administrative time and normally result in no lapse in membership.

#### **Starry Stonewort Report**

Dawn Griffin and Lucianna Adragna have worked on better understanding the invasive Starry Stonewort situation. There is a lot of research into how to control starry stonewort (SSW), but there is currently no way to permanently evict it from our lake, so stopping the spread is the most important thing we can do.

The short story is that SSW is an invasive plant that:

- creates thick matted "deserts" where native aquatic plant species, fish, insects, etc.
  cannot survive
- establishes new colonies from just a tiny fragment of the plant so it spreads very easily (e.g. by swimming or boating through infested areas)
- is difficult to impossible to eradicate; and
- is spreading quickly through Ontario waterways.

We have included a map on our website Environment page to show confirmed locations of Starry Stonewort. If you see it in other locations, let us know. We'll investigate and add it to the map.

#### **Social Committee Report**

When I joined the board in 2014 I had one requirement which was permission to create the regatta. There weren't any planned kid activities at that point and I had an idea in my head from our previous cottage that I wanted to do, a movable location regatta. With the regatta only being on water for last two years, kids aren't meeting like they used to.
